



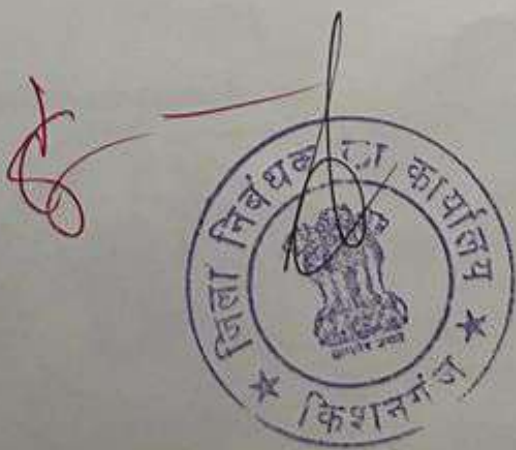


- n) To amalgamate the Trust with other association, Trust or organization having public charitable objects and purposes with the consent of two third of Trustee in writing.

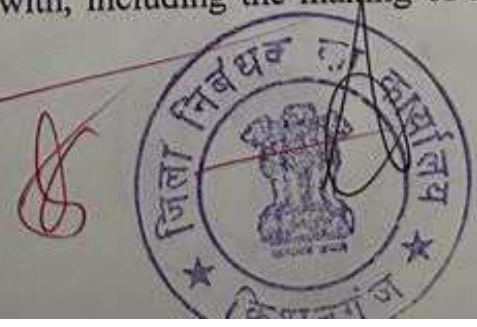

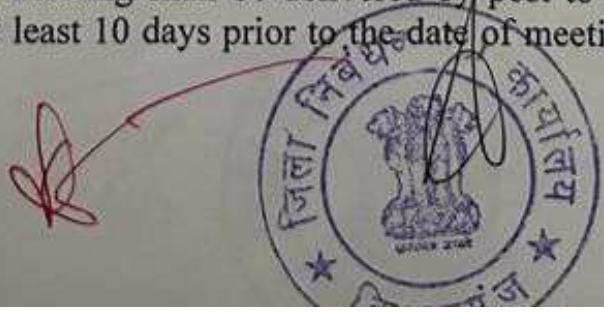
- f) To accept donations, grants, presents, gifts and other offerings in the shape of moveable and/or immovable properties for the attainment of the aims and objects of the Trust.






